An experienced CDMO should possess a well-rounded team, ensuring all aspects of your project—from regulatory compliance to material sourcing—are managed effectively. Their historical success with similar projects can reduce risk and streamline development.

Facilities and Equipment

The CDMO's facilities and equipment should be state-of-the-art, well-maintained, and compliant with regulatory requirements. Assess whether they have the necessary infrastructure to accommodate your project's current and future needs.

Switching CDMOs due to scale or phase transitions can be costly and time-consuming. Selecting a partner with the capacity to support long-term development minimizes these challenges.

Quality and Compliance

Cost and Timeline

Balancing cost, quality, and speed is crucial. While cost-effective solutions are desirable, an unrealistically low price or expedited timeline may signal potential compromises in quality or project execution.

Accelerating a project often requires additional resources (which increases costs), scope reductions, or riskier trade-offs. A strategic approach ensures that efficiency gains do not come at the expense of regulatory compliance or long-term viability.

Assessing Their Fit as a Partner

Communication and Collaboration

Engaging a CDMO is a long-term commitment, requiring effective communication and collaboration. Challenges related to technical execution, logistics, or priority alignment will inevitably arise, making strong interpersonal relationships essential.

Look for a CDMO that fosters transparency, responsiveness, and proactive problem-solving. The strength of their communication will directly impact the efficiency and success of your project.

Request references from past clients to gain insights into their working relationships. Key considerations include:

- Do they provide honest and timely project updates?
- Are they proactive in identifying and presenting solutions to potential challenges?
- How well do they manage projects without requiring constant oversight?
